

As a courtesy, the Presbytery attempts to provide driving directions and parking information (when known) to all the members attending the Assembly.

Due to the size of the presbytery, we are unable to include all possible routes to the meeting. The directions we provide begin with major routes into the city/town where the assembly will be held, and include more detailed directions regarding the streets closer to the meeting site. Please use an online source or printed map to find the way from your starting point to the place where these directions begin. The POV website has all church locations marked on Google Maps to assist you.

There may be construction or detours that would affect normal routes of travel. To be prepared for this possibility, it is wise to have a map, Google map printout, or GPS navigation available, just in case. You can also check the Indiana Department of Transportation website for Road Restrictions and Closures: https://www.in.gov/indot/travel-conditions/restrictionsclosings/

The church is located at the corner of Sycamore and Washington Streets, one block east of the downtown square. The best parking options are along both sides of Washington Street. See more info about parking below.

NOTE: If you would normally use IN 252 from Morgantown, be advised that the road is closed for bridge construction work in both directions, between Sedwick Rd (1 mile east of the Painted Hills area) and S Whetstine Rd (1 mile west of the Morgantown area).

For those traveling on I-69 (north or south):

- Take I-69 to exit 138 Ohio Street.
- Take Ohio Street North to Washington Street, and turn Left.
- The church will be two blocks ahead on the right.
- The church doors are numbered. Please enter through door #1 (facing Sycamore St.) or #3 (facing Washington St.)

For those traveling on U.S. 67 (north or south):

- Turn onto Hwy 39 at stoplight (right if northbound on 67, left if southbound).
- Cross the bridge and turn left at the stoplight onto Morgan Street.
- Continue East on Morgan several blocks to Sycamore Street, turn Right and go one block, and then turn left onto Washington. The church will be on the immediate left.
- The church doors are numbered. Please enter through door #1 (facing Sycamore St.) or #3 (facing Washington St.)

Parking

Parking is available on either side of Washington street (no meters). Parking is also available in certain lots near the church. There is a small bank lot and a City lot on the other side of Sycamore Street, and there is the Family Dollar parking lot behind the church, off of Morgan Street. There is also a larger public lot available one block East of the church, off of Morgan and Wayne Streets, next to the EggcellentDay restaurant.

Report of the Presbytery Council

The Rev. Susan McGhee, Moderator

For Presbytery's Information

The Presbytery Council conducted an electronic vote June 8, 2025:

1. Acting as a Commission of Presbytery, appointed Ruling Elder Alan Harder to serve as Moderator of Session for Cayuga Presbyterian Church, and commissioned him to this service.

The Presbytery Council conducted an electronic vote June 19, 2025:

1. Acting as a Commission of Presbytery, appointed Ruling Elder Joe Kimmel to moderate a Congregational Meeting at Vernon Presbyterian Church on June 22, 2025, and commissioned him to this service.

The Presbytery Council met July 8, 2025, by videoconference:

1. Received information that the Smock Foundation will now be incorporated. Under the new bylaws, The Presbyteries of Ohio Valley, Wabash Valley, and Whitewater Valley shall each appoint three Directors. For each Presbytery, the executive presbyter or head of staff (or that person's designee) will serve as that Presbytery's "Designated Director." Each Presbytery shall name two additional Directors using that Presbytery's rule or policy for making appointments and each named Director may be a Minister of Word and Sacrament, employee of the Presbytery, or a deacon or ruling elder member of one of the congregations within the Presbytery.

Susan McGhee serves as the Designated Director. Alicia Holt, who has been on the Distribution Advisory Committee, will continue her role, now as a Director. The Presbytery Council named the Rev. Alan Finnan to serve as a third Director.

The Presbytery Council conducted an electronic vote July 29, 2025:

1. Acting as a Commission of Presbytery, appointed Susan McGhee to serve as Temporary Stated Clerk during Joe Kimmel's vacation, August 14 – 25.

The Presbytery Council conducted an electronic vote August 2, 2025:

1. Acting as a Commission of Presbytery, appointed Ruling Elder Joe Kimmel to moderate a Session meeting for First Presbyterian Church, Bedford and commissioned him to this service.

- 2. Approved a request from the Nominating Committee for a provisional change to the composition of the Presbytery Council in the Presbytery Design and Committee Structure to read as follows, and to be presented to the presbytery for approval at its assembly November 20, 2025:
 - The moderators of each of the standing committees of the Presbytery, the moderator of the Personnel Committee, four three at-large members representing the geographical diversity of the presbytery, the Moderator, Vice- Moderator, and immediate past Moderator of the Presbytery, the Stated Clerk, Treasurer (if that person is a ruling or teaching elder), and Executive Presbyter (who shall serve as moderator).
- 3. Acting as a Commission of the Presbytery, appointed the Rev. Heather Theissen as moderator of session for Trinity United Presbyterian Church, New Washington.
- 4. Agreed to recommend that 2026 Assemblies be held Saturday, February 28; Thursday, May 21; Saturday, August 22; and Thursday, November 19.
- 5. Considered matters related to the Stated Clerk's position, in light of Joe Kimmel intention not to stand for a third term:
 - a. Appointed Joe Kimmel to serve as Acting Stated Clerk (his second three-year term has drawn to a close), effective immediately and through December 31, 2025
 - b. Voted to nominate the following persons to serve on a Stated Clerk Search Committee:
 - i. Rev. David Crittenden (Former Stated Clerk and President of the Board of Trustees)
 - ii. Rev. Wendy VanderZee (Moderator of the Presbytery)
 - iii. Rev. Deborah Fortel (Moderator of the Presbytery Nominating Committee)
 - iv. Ruling Elder William Henderson (Representative from the Committee on Ministry)
 - v. Ruling Elder Karen Walker (At-large Member of the Presbytery Council)

<u>Background</u>: Presbyterians have a form of government built upon shared authority and mutual accountability as we seek together to find and represent the mind of Christ. In addition, Per Capita funds the constitutionally required functions of each body.

In addition, congregations are encouraged to add a SECA (self-employment tax) offset of 7.65% of total effective salary.

PROFESSIONAL EXPENSES

The following amounts will be made available to the minister, for reimbursement of professional expenses through the presentation of vouchers.

- Vouchered Auto Mileage Reimbursed at current IRS rate (Note: As of January 1, 2025, value is 70.0 cents/mi)
- Continuing Education (cumulative over 3 years to sum of annual amounts): \$1200 (ordained clergy and commissioned pastors); however, it is strongly recommended that up to \$2,000 be offered to cover 2 weeks of tuition, room and board, travel

BOARD OF PENSIONS (BOP) BENEFIT PLAN

Employing organizations will pay regularly in advance to the board responsible for benefits a sum equal to that requisite percent of effective salary (salary + housing or 30+% of salary, utilities, and any deferred compensation) which may be fixed by the General Assembly of the Presbyterian Church (USA) including pension, medical coverage, and death and disability benefits. For pastors working over 20 hours per week, who are not members of the Board of Pensions, a comparable amount will be paid to their denomination's plan or other mutually-agreed-upon retirement program.

The Board of Pensions has adopted a new benefits plan, beginning in 2025, that no longer requires congregations served by installed pastors to cover health insurance for spouses and children. A more flexible plan is being offered that gives congregations the option to offer family coverage, although coverage may be more costly. Medical coverage for pastors <u>and</u> their families continues to be both a value and an expectation for congregations served by installed pastors, as well as those whose pastors are serving in non-installed positions for at least 20 hours a week. *Minimum pastoral compensation in the Presbytery of Ohio Valley includes health insurance coverage for pastors and families, to be paid by the congregation.* Terms of call for installed pastors and pastoral agreements for temporary pastors will include a statement indicating how this coverage will be provided. Possibilities may include insurance provided by a spouse's employment or purchased through the market place.

It is not the intent of this policy to create a hardship for congregations or pastors. The Presbytery, working through its Committee on Ministry and Presbytery Staff, is committed to helping congregations and pastors navigate these changes.

²To calculate Cash Salary portion of a 30% Manse Value, divide Total Cash Salary including Manse amount (above example for ordained clergy being \$58,486) by 1.3 to get the Cash Salary portion.
